

OFF-LICENCE

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

Licence No: 058/OFF/00004/2023

Pursuant to the Sale and Supply of Alcohol Act 2012 (The Act), **Toffee Limited** (the licensee) is authorised to sell alcohol on the premises situated at **320 High Street Rangiora** and known as **Super Liquor Rangiora**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS -SECTION 116 (1-2)

- (a) No alcohol may be sold or delivered on Good Friday, Easter Sunday, Christmas Day or before 1 pm on ANZAC Day.
- (b) Alcohol may only be sold or delivered on the following days and during the following hours:

Monday to Sunday from 8.00am to 10.00pm

- (c) Water must be freely available to customers, while alcohol is being supplied free as a sample on the premises.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed;
- Display of appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition of sales to intoxicated persons.
- (e) The following steps must be taken to ensure that the provisions of the Act relating to the management of the premises concerned are observed:
- Alcohol must only be sold and supplied within the area marked on the plan submitted with the application.
- (f) The following step must be taken to promote the responsible consumption of alcohol:
- the licensee must implement and maintain the steps proposed in their Host Responsibility Policy aimed at promoting the reasonable consumption of alcohol.

The Bottle Store shall be designated as **Supervised**

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE


A copy of this licence must be displayed at each of the principal entrances to the premises.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force –

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period for which it is renewed.
